

You need to file for a temporary clearance. Here are the requirements:

The following must be submitted at least 2 weeks before leaving:

1. Letter of request addressed to the ERDT Project Leader stating the reason for travel, inclusive dates/duration). The letter must be endorsed by your thesis/dissertation adviser.
2. Notarized Deed of Undertaking (see attached file). Please take note the CTC/sedula is no longer accepted. Just indicate the valid I.D. numbers.
3. Assigning a co-maker is required upon filing this request. Please note that the Co-maker is supposed to be residing in the Philippines and is not part of the travel/trip abroad. Kindly attach the co-maker's proof of income (Recent Certificate of Employment or Income Tax Return (ITR)).
4. Photocopy of valid I.D declared in the deed of undertaking: scholar & co-maker.
